# Environmental impact of the healthcare sector

Water consumption in hospitals can range from 180 to 1400 liters per capita per day, depending on hospital size, services and efficiency

Wastewater may contain various pollutants.

Pharmaceutical products in water can have significant negative impacts on ecosystems and human health. • Disrupting aquatic life

• Affecting the endocrine systems of animals

Contributing to antibiotic resistance









## **Environmental impact of the healthcare** sector

Healthcare is responsible for between 4 and 5% of global greenhouse gas (GHG) emissions, and is considered the fifth largest emitter on the planet when compared to the activity of a country

## Many initiatives in the healthcare sector

Some countries are adopting circular economy strategies, decarbonization plans or roadmaps:

The Netherlands - Green Deal on Sustainable Healthcare (LINK)

Spanish Ministry of Health - is promoting the necessary regulatory framework for the system to be decarbonised by 2050 (LINK)

Denmark has designed a strategy to reduce the impact of the sector and accelerate its transition and in 2020, Danish Regions sat the goal for all public hospitals to reduce by 2030 75% of their  $CO_2$  (LINK)

UK: Design for Life roadmap - A government's plan to build a circular economy for medical technology to increase resilience, drive growth, realise cost savings and improve sustainability (LINK)







Other interesting initiatives:

France: A very advanced Extended Producer Responsibility System for sharps waste generated by private households (DASTRI). Is the only country in the world with a regulated collection system for this type of waste that covers the whole country.

Since 2022 also sharps that are WEEE! (LINK)

Others: Refurbished medical equipment and devices, ambulances.

A huge number of initiatives and actions being implemented by different hospitals and HC centres.

#### 3 Core elements

#### Performance

Actions implemented by the organisation improve environmental performance and ensure legal compliance, in line with key policy targets (Circular Economy, Climate Change, Biodiversity protection, etc.).

#### Transparency

Achievements are made public through the annual environmental statement.

#### Credibility

The environmental statement is validated by independent environmental verifiers who guarantee the value of the information disclosed.
